

LEGAL NOTICES – ADULT CONTENT AND PRIVACY

Notice – Adult Content

This website contains content intended exclusively for an adult audience. By accessing the site, the user declares and warrants to be at least 18 years old, that access to such content is permitted by the law of the country from which they are connecting, that they are accessing the site voluntarily and knowingly, and that they do not consider adult content offensive or unlawful. Specific Notice – Sections with Adult Content

The Platform Owner exclusively provides a technical hosting and publishing service and does not participate in, organize, promote, or act as an intermediary for sexual activities or prostitution. Each piece of content is published under the sole responsibility of the user who uploaded it. Exclusion of Intermediation

The platform does not provide, organize, act as an intermediary for, or facilitate prostitution or sexual services. Any contact between users takes place exclusively outside the platform and under their sole responsibility. The Owner does not receive any compensation related to sexual services, nor does it take part in economic relationships between users.

Privacy and Cookies

The site uses technical cookies and, subject to user consent, analytics and profiling cookies in order to improve the browsing experience. Personal data is processed in compliance with EU Regulation 2016/679 (GDPR). By continuing to browse or by giving consent through the tools made available, the user accepts the use of cookies as set out in the extended privacy policy, always available on the site.

Processing of Personal Data in Sections with Profiles and Images

The profiles, images, and content published in the site's sections are uploaded voluntarily by users, who declare that they have full rights over the data and images used and that they act in compliance with applicable law. It is prohibited to publish content depicting minors, content uploaded without the consent of the person concerned, as well as unlawful, violent, or illegal content. The Platform Owner acts as a hosting service provider and removes content reported as unlawful in accordance with the procedures set out by applicable law.

Reporting Content

Anyone who believes that content published on the site is unlawful or infringes on rights may submit a report by sending a communication to the contact details indicated in the contacts section, specifying the URL of the content, the reason for the report, and any supporting documentation. Reports will be reviewed promptly.

User Responsibility

The user is solely responsible for the use of the site and of the content viewed or uploaded. The Owner is not liable for any use contrary to the law, to these notices, or to the platform's terms and conditions.

Refund Policy

This Refund Policy governs the refund procedures applicable to the services offered through the NOQ platform.

The user acknowledges that the digital content purchased on the platform consists of digital content provided immediately after payment and that, pursuant to applicable law, the right of withdrawal may be excluded once use of the content has begun.

However, NOQ may consider refund requests in the following cases:

- technical malfunctions attributable to the platform that prevent access to purchased content;
- incorrect or duplicate charges;
- content removed for policy violations prior to its use.

Refund requests must be submitted through the dedicated support channel indicated on the site, within a reasonable time from the purchase, providing all information necessary for verification.

NOQ reserves the right to evaluate each request on a case-by-case basis and to refuse refunds in the event of abusive or fraudulent use.
